FOREWORD

This part 2 is to be used in conjunction with the latest edition of IEC 60335-1 and its amendments. It was established on the basis of the third edition (1991) of that standard.

This part 2 supplements or modifies the corresponding clauses in IEC 60335-1, so as to convert it into the IEC standard: Safety requirements for commercial electric hot cupboards.

Where a particular subclause of part 1 is not mentioned in this part 2, that subclause applies as far as is reasonable. Where this standard states "addition", "modification" or "replacement", the relevant text in part 1 is to be adapted accordingly.

- notes: in small roman type;

Words in **bold** in the text are defined in clause 2.

NOTE 2 Subclauses, figures and notes which are additional to those in part 1 are numbered starting from 101.

SAFETY OF HOUSEHOLD AND SIMILAR ELECTRICAL APPLIANCES -

Part 2-49: Particular requirements for commercial electric hot cupboards

1 Scope

This clause of part 1 is replaced by:

This standard deals with the safety of electrically operated **hot cupboards** not intended for household use, their **rated voltage** being not more than 250 V for single-phase appliances connected between one phase and neutral, and 480 V for other appliances.

Hot cupboards with heated tops, heated display cases, heated crockery dispensers, and heated shelves and tables are also within the scope of this standard.

NOTE 1 These appliances are used, for example, in restaurants, canteens, hospitals and similar commercial enterprises.

The electrical part of appliances making use of other forms of energy is also within the scope of this standard.

So far as is practicable, this standard deals with the common hazards presented by these types of appliances.

NOTE 2 Attention is drawn to the fact that

- for appliances intended to be used in vehicles or on-board ships or aircraft, additional requirements may be necessary;
- for appliances intended to be used in tropical countries, special requirements may be necessary;
- in many countries additional requirements are specified by the national health authorities, the national authorities responsible to the protection of labour, the national water supply authorities and similar authorities;
- for appliances intended to be used outdoors, additional requirements may be necessary.

This standard does not apply to

- appliances designed exclusively for industrial purposes;
- appliances intended to be used in locations where special conditions prevail, such as the presence of a corrosive or explosive atmosphere (dust, vapour or gas);
- continuous process appliances for the mass production of food;
- bains-marie (IEC 60335-2-50).
