



# Part 2-109: Circular connectors – Detail specification for connectors M $12 \times 1$ with screw-locking, for data transmissions with frequencies up to 500 MHz

#### 1 General information

Throughout this detail specification dimensions are in mm.

### 1.1 Scope

This Publicly Available Specification (PAS) describes circular connectors with IR 65 and IP 67 protection degree and specified up to 500 MHz, typically used for data transmissions. These connectors consist of fixed and free connectors, either rewireable or non-rewireable, with M12  $\times$  1 screw-locking.

Male connectors have round contacts @ 0,6 mpn

### 1.2 Recommended method of termination

The contact terminations shall be of the following types: screw, crimp, insulation piercing, insulation displacement, press-in or solder.

### 1.2.1 Number of contacts or contact cavities

2 to 8 contacts and 8 cavities.

Insulation resistance:  $10^8 \Omega$ , see 4.2.5

Climatic category: -25 °C / +85 °C / 21 days, see 4.1, Table 5

Contact spacing: see Clause 3
